Hilda Geiringer Lecture Series 2013

CRC 649 "Economic Risk" started the Hilda Geiringer Lecture Series to honor the mathematical and statistical contributions of Hilda Geiringer. She was the first woman to receive an academic appointment in mathematics at the University of Berlin in the 1920's and therefore is a role model for women in science. Distinguished female scientists are invited to give a talk at the Hilda Geiringer Lecture Series.



Hilda Geiringer Lectures 2013 'Nonstationary Panels' were given by Yoosoon Chang from 8 to 9 July 2013 in the Festsaal of Humboldt-Universität zu Berlin. Yoosoon Chang is a Professor of Economics at Indiana University Bloomington. Her research interests are in time series and panel data models and their applications in macroeconomics and finance.

She is an associate editor of *Time Series Econometrics*, a program committee member of the *International Symposium on Econometric Theory and Applications*, an external fellow of the Granger Centre for Time Series Econometrics at Nottingham University, and an external associate of the Centre for Econometric Analysis at Cass Business School in London.

Yoosoon Chang gave four excellent lectures on topics as panel unit root tests, panel cointegration analysis, analysis of state distributions using pseudo panels and panels at high frequency. We were pleased to welcome Yoosoon Chang at CRC 649 and wish her further success in her research. (MO)


